AGREEMENTS, LEASES, AND GRANTS

- A. Authorization for Rankin County Sheriff's Office to submit request for sole source procurement approval to Mississippi Department of Homeland Security related to pending agreement between Rankin County Sheriff's Office and Flock Group, Inc., for the potential purchase of the vendor's audio/visual surveillance

technology and related services. Contingent upon approval of Mississippi Department of Homeland Security Approval for the Rankin County Sheriff's Office to engage in a sole source purchase of said equipment and services, authorization of Rankin County Sheriff's Office to execute Scope of Work and Master's Services Agreement to purchase and install said equipment.

Authorization for Rankin County Sheriff's Office to execute all documents/agreements/approvals that may be necessary as a part of this transaction. Cost of equipment/peripherals/software is \$64,200. Cost of professional services for installation and implementation is \$24,000. Total cost is \$88,200. All costs for equipment and installation, plus cost for year one software maintenance, are covered by grant funding available to the Rankin County Sheriff's Office. To the extent that grant funding becomes unavailable after year one, the Rankin County Sheriff's Office would be required to cover the costs of software maintenance or other costs going forward. Contingent upon approval of Mississippi Department of Homeland Security Approval for the Rankin County Sheriff's Office to engage in a sole source purchase of said equipment and services, authorization for County Administrator or Rankin County Purchase Clerk to issue purchase orders for said equipment and services as sole source items and authorization for issuance of payment for all items/services properly invoiced

- B. Acknowledgment of receipt of sole source justification correspondence from Stryker Corporation, manufacturer of Stryker brand life-saving medical products dated August, 2025, wherein is contained product, service and warranty descriptions for all Life-Pak systems and products manufactured under the brand name, STRYKER, as well as, product, service and warranty descriptions for products manufactured under the STRYKER brand name. No other supplier/vendor is able to offer a warranty or warranty-related service for such devices.
